All bid/tender documents and PQ documents are to be submitted online only and in the designated cover(s)/envelope(s) on the e-GP website, Technical bid and financial bid shall be submitted in their respective designated online covers. Tenders/bids shall be accepted only through online mode on the e-GP website and no manual submission of the same shall be entertained. Late tenders will not be accepted.

Registration certificate duly attested by a Gazetted Officer, Preliminary agreements, bid capacity certificate and EMD Exemption certificate (if any) shall be submitted online and subsequently in a separate cover physically through speed post before the time prescribed. More details on EMD and cost of tender documents/bid submission fee are mentioned in the Form 83 document.

The technical bids shall be opened online at the office of the Registrar, Sree Sankaracharya University of Sanskrit, Kalady on the date mentioned above by the Registrar in the presence of bidders/their representatives who wish to attend at the above address. If the tender opening date happens to be on a holiday or non working day due to any other valid reason, the tender opening process will be done on the next working day at same time and place.

Online tenders/bids are to be accompanied with a preliminary agreement executed in Kerala Stamp Paper worth Rs.200/-. Tenders/bids received on line without registration certificates duly attested by a Gazetted Officer, Preliminary agreement, bid capacity certificate (completion certificate) and EMD exemption certificate (if any) will not be considered and shall be summarily rejected. The firm period of the tenders shall be 120 days from the date of opening of the price bid. Besides, Security Deposit @ 5% of the contract value shall be remitted to the University, at the time of executing the agreement. 50% of the deposit shall be in the form of Treasury Fixed Deposit.

The bidder is advised to submit the bids well before the stipulated date and time to avoid any kind of network issues, traffic congestions etc. In this regard, the University shall not be responsible for any kind of such issues faced by the bidder. All other existing conditions related to PQ Tender of PWD will be applicable in this tender and also all subsequent Government Orders connected with tenders.
