

SSUS -Admn -Appointment of Sri.K Aravindakshan as Lecturer in Music provisionally under 3% reservation for physically challenged category (Blind)-Sanctioned -Orders issued.

**ORDER**

Sri.K.Aravindakshan, Pullayil House, Pompra P.O., Karakurissi (Via), Palakkad - 678 595 vide his request read as 2<sup>nd</sup> above has requested to Government that his candidature for the post of Lecturer in Music on regular basis may be considered benignly.

Upon his request, the Government, vide its letter dated 24.07.2009 has clarified that, if Sri.K.Aravindakshan is appointed against a post on the basis of assessed workload, there is no legal barrier in appointing him on regular basis and directed to report the Government on the matter. Sri.K.Aravindakshan was qualified UGC NET, during December 1999 and acquired MA (Music) degree - 1999 from University of Calicut with 59% marks.

As per the statement of workload submitted by HOD of Music, it is found that there exists sufficient workload to accommodate a regular teacher even though, there is no sanctioned post in that department.

The matter was reported to 94<sup>th</sup> meeting of the Syndicate held on 22.09.2009 item No.18 and the Syndicate resolved to appoint Sri.K.Aravindakshan, as Lecturer in Music on regular basis under visually handicapped category as a special case imbibing the spirit of the Government letter read as 3<sup>rd</sup> above. The matter was again reported to Syndicate for formulating the guidelines while making appointment to physically challenged person. The Syndicate in its 102<sup>nd</sup> meeting held on 04.09.2010 additional agenda item No.7 has considered the matter and resolved to approve the guidelines vide U.O. read as 1<sup>st</sup> above.

The Syndicate also resolved to appoint Sri.K.Aravindakshan, as Lecturer in Music on regular basis imbibing the spirit of the Government Letter read as 3<sup>rd</sup> above under intimation to Government.

In the above circumstances, the Vice Chancellor has accorded sanction to implement the resolution of the 102<sup>nd</sup> meeting of the Syndicate held on 04.09.2010 additional agenda item No.7, to appoint Sri.K.Aravindakshan, Pullayil House, Pompra P.O., Karakurissi (Via), Palakkad - 678 595 provisionally as Lecturer in Music in the pre-revised scale of Rs.8000-275-13500+ DP supernumerarily under 3% reservation for physically challenged - Blind category subject to approval from the Government. This appointment will be adjusted against the turn of 33 marked for blind / low vision category in the department of Music in future.
