ORDER

The University had invited applications from among the qualified candidates for teaching posts in various Departments for regular appointments. Application for teaching posts in traditional subjects/ Fine Arts under the category of Tutor/Instructor/Demonstrator were also invited in which painting is one of the subjects. Consequently, rank list for the appointment to the post of Tutor in Painting was published on 08.12.1997 after conducting selection committee meeting which was held on 21.11.1997. Sri Sreegopan BS, Greenkothan, Machel PO, Thiruvananthapuram - 695 571 was ranked as 'Third'. Since, there were only two posts, Sri Sreegopan could not be inducted in the select list. Subsequently, Sri Sreegopan approached the University to appoint him on regular basis, but the request could not be entertained as there was no vacancy and the validity period of the rank list had expired.

Sri Sreegopan approached the Hon'ble High Court of Kerala to redress his grievances through the writ petition read as 1st above, and the hon'ble High Court ordered on 24.10.2005 to consider the request of Sri Sreegopan with a noting that, due regard has to be given to the situation that a person by name Sri OP Johnson was absorbed in the permanent cadre after the expiry of the rank list.

The 64th meeting of the syndicate, while ratifying the appointment of Sri OP Johnson as Tutor in Sculpture, decided to approach the Govt. to create one post of Tutor in Painting vide paper read as 3rd above. The Govt. vide its letter read as 4th above, has suggested that, Sri Sreegopan BS may be appointed to any one of the vacancies arising in future as was done in the case of Sri OP Johnson.

Meanwhile, a regular post of Tutor, upgraded as Lecturer in Painting fell temporarily vacant w.e.f 31.07.2008 due to the relief of Sri Babu K, Lecturer in Painting after retainering him for two years. Sri Sreegopan was appointed against this vacancy as Tutor in Painting on temporary basis, after downgrading the post of Lecturer in Painting w.e.f F.B. of 01.03.2009. On rejoining of duty by Sri Babu K as
