ORDER

Dr. Tony K. Raphel, the teacher engaged on contract basis in the University filed a WP (C) No. 9281/12 of the Hon'ble High Court of Kerala seeking regularization of his service in the Department of Malayalam of the University.

The Hon'ble High Court of Kerala vide its judgment read as above after considering the contentions taken by petitioner and the University and the principles in various reported settled cases of the Hon'ble Supreme Court of India, declared the judgment directing the University to take immediate steps to regularize the service of the petitioner as Assistant Professor in the Department of Malayalam. The Hon'ble High Court of Kerala while declaring the judgment has explained all the details of the notification dated 05.09.1997 and regular selection after publication of the rank list in accordance with statutory provisions held in 1998, the rank position of the petitioner in its rank list of the Department of Malayalam, financial constraints and lack of sanctioned posts, continuation of the contract teachers and perennial teaching requirements etc. concerning the facts and circumstances specifically applicable to the petitioner.

Vide paper read as 2nd above, the Syndicate considered the matter and resolved to implement the judgment and resolved as below. The Vice Chancellor pointed out that the regularization of Dr. Tony K. Raphel is against the provisions contained in the University Act and Statutes. However, by considering the direction of the Hon'ble High Court of Kerala, the Vice Chancellor requested for a detailed discussion in this regard. The Syndicate, after a detailed discussion, resolved to comply with the direction of the Hon'ble High court of Kerala and decided to issue consequential orders to appoint Dr. Tony K. Raphel in the Department of Malayalam against the reported vacancy of Assistant Professor in accordance with the judgment dated 28.06.2016 in WP (C) 9281/12. Also resolved not to grant back arrears and service benefits to the incumbent.

Sanction has therefore been accorded by the Vice Chancellor to appoint provisionally Dr. Tony K. Raphel, Pulari, Civil Lines Road, Poothole P.O, Thrissur- 680 004 by regularizing

him to the post of Assistant Professor in the Department of Malayalam in the pay band of ₹15600-39100 AGP 6000 implementing the aforesaid resolution of the Syndicate, w.e.f. 01.12.2016 on the date of reopening of classes after semester break during November 2016. He will not be eligible for the back arrears and the service benefits prior to 01.12.2016.

The appointment of teacher will be entered against open vacancy as and when arises in the Roster of Appointments of Assistant Professor.

The appointee will be on probation for a period of one year within a continuous period of two years from the date of joining.

Orders are issued accordingly.
