The University vide U.Os. read as 1st above, had implemented the "Scholarship for Encouraging Sanskrit Studies under U.G. Programme" with Guidelines detailing the procedure, eligibility and conditions of the scheme.

The Syndicate vide paper read as 2nd above, has resolved the revised Budget for 2017-'18 and Budget Estimate for 2018-'19, wherein the amount of scholarship for encouraging Sanskrit Studies under U.G.Programme has been revised to Rs.500/- from 350/- per month. The amount will be disbursed to the students from the second month of their admission itself. The entitlement for scholarship will be purely on the basis of 75% attendance. No other criteria is considered essential for the disbursement of the scholarship in subsequent years.

Sanction has therefore been accorded by the Hon'ble Vice Chancellor to amend the Guidelines issued vide U.O. read as 1st above dated, 19.02.2018 revising the Clause (3) to effect the rate of Scholarship as Rs.500/- per month w.e.f. 2018 admission onwards.
