RULES & REGULATIONS FOR CONDONATION OF SHORTAGE OF ATTENDANCE

- 1 The Vice Chancellor shall be the authority to grant condonation of shortage of attendance.
- 2. The provision of condonation per semester will not be a matter of course, nor equally will it be claimed as a matter of right on the part of the student. However, at the same time, it is permitted in genuine cases where the Vice Chancellor is satisfied that the student could have attained a minimum of 80% of attendance, but for reasons / matters beyond the normal control of the student.
- Condonation of shortage of attendance shall be available to a maximum of 20% or part thereof
 in an academic year for appearing in the University Examinations for BA/BFA/MA/MSW
 Degree Course.
- 4. In cases of shortage of attendance due to illness, proper medical certificate should invariably be attached to the application.
- An amount of Rs. 100/- (Rupees One hundred only) must be remitted and Acknowledgement for Receipt of money as fee therefor attached to the application.
- 6. Application completed in all respects should reach the Registrar 15 days in advance of the University Examination.
- 7. Application without conforming to the rules is liable to be rejected without any intimation.
