The Monitoring Cell on Ragging will co-ordinate all the institutions affiliated to it by calling for reports from the Heads of such institutions regarding the activities of the Anti-Ragging Committees and Squads. Monitoring Cell shall observe and check the activities and its compliance with regard to the instructions on conducting orientation programmes, counseling sessions etc., and regarding the incidents of ragging, the problems faced by wardens and other officials, etc. The cell shall also review the efforts made by such institutions to publicize Anti-Ragging measures, cross-verify the receipt of undertakings form candidates/students and their parents/guardians every year and shall be the prime moves for initiating action by the University authorities to suitably amend the statutes or ordinances or Bye-laws to facilitate the implementation of anti-ragging measures at the level of the institution.
