Orders are issued accordingly.



**Guidelines for Online Teaching During Corona virus
Pandemic - June 2020**

Guidelines for Online Teaching - SSUS, 2020 is being issued in the face of the Novel Coronavirus pandemic that has kept educational institutions shut and made the usual class room teaching/ learning impossible. In the face of the fact that the students should not lose out in the learning process, educational institutions world over have resorted to online teaching. Though not a substitute for classroom - centred pedagogical practices, guidelines to set measures for a continued academic dialogue, involving teaching and assessment, between students and teachers is being brought.

- I. **Name:** These Regulations will be called **Guidelines for Online Teaching During the Corona virus Pandemic - SSUS, 2020**. The guidelines seeks to chart out the systematic conduct of UG, PG, MPhil and Pre-Phd Course Work Programmes, included in the syllabi and scheduled for the Monsoon semester 2020, in an online mode. These guidelines will cease to be valid once regular classroom teaching/learning processes are resumed.
- II. **Frequency of Classes:** At least three live sessions of 30 minutes each duration for each Course should be provided to the students on a weekly basis. Taking internet connectivity and access issues into consideration, the timings for these sessions may be worked out according to the convenience of the students and the faculty member offering the Course. These sessions may be used to deliver lectures, discussion on contents/resources provided in order to further the students' learning experiences.
- III. **Content Offered :** Students who are unable to access libraries or other repositories are not in a position to supplement the lectures provided by the Faculty members. Hence, diversified learning resources like reading materials, soft copies of books, video /audio clippings, charts, archival data and other resources may be provided either through the University's LMS platform or through any other platforms used by the teachers, for the students to access at any time

of their convenience. These resources have to be uploaded for each module/unit of the syllabus.

- IV. Platform:** Live sessions may be conducted on suitable platforms, viz., Big Blue Button in Moodle, Zoom, Google Meet, Webex , etc.
- V. Accountability:** Since attendance of students is an essential requirement for their appearance in end semester examinations, this has to be registered regularly. The existing attendance requirement shall be adhered to. Attendance can be marked by the students on the course page of the online platform they are provided by their teachers upon the basis of page visited to access resources as well as in live sessions attended. Students are expected to visit their course page on all working days and mark their attendance there. Teachers shall record attendance of their live classes. Teachers may forward monthly attendance of both these to the Heads of Departments who may forward the attendance sheets to the University.
- VI.** The academic calendar of the University may strictly be followed in conducting teaching and assessments.
- VII. Assessment:** In a revision of the existing Regulations of PG Programme, the assessment modules may be made flexible to choose from the diverse activities available on online platforms like Assignment , Answering questions after reading an article/material, Workshop, Forum, Quiz, Glossary, Lesson, etc. In the absence of such facilities in the software used, teachers can ask the students to submit their assigned work through any other means. If more than three activities in each category (assignment, exam etc.) for assessment have been employed, the highest grade received by the student in a category may be considered for official grading purposes of internal assessment. Or its average can also be considered for calculating grade.
- VIII. End semester Exam :** End semester Examination shall be conducted by the university in the existing manner.


Considering the matter, the Vice Chancellor has accorded sanction to implement the aforesaid Government Order in the University, subject to the ratification by the Syndicate.
